President Roxie reported that all of the candidates that Local 7 had endorsed for the November 2022 Maryland elections, won. Especially exciting is the election of Wes Moore as Governor making him the first African American to fill the office.

Financial Secretary Krista Strothmann reported on the success of our Hospitality Training Academy.

President Roxie shared with members that we will hold the 2023 Black Leadership Gala. The planning committee is open to all members. Tickets will go on sale in the New Year. She said that the committee is still looking for a venue. We expect a crowd of 300.
